Requirements and Assessment Changes

This memorandum provides information on the roadmap for a comprehensive approach to Social Studies, discussed at the September 2014 meeting of the Board of Regents, which followed the Board's approval of the New York State K-12 Social Studies Framework. In January 2015, the Board approved pathways to graduation and various changes to the social studies requirements. <u>Implementation Schedule</u>

It is important for teachers and administrators to be familiar with the Social Studies standards and practices that are identified in the New York State K-12 Social Studies Framework. We strongly recommend that districts begin now to align existing curriculum in K-12 social studies with the Frameworks and implement instruction in <u>not tested grade levels</u> (K-8 and 12) no later than the start of the 2015-16 school year. The new Global History and Geography II¹ Regents Exam will be first available in June 2018; the new US History Regents Exam will be first available in June 2019. To prepare students to meet these high school assessment requirements in social studies, students should be instructed in the content and the social studies practices found in the new framework for the Global History and Geography I (grade 9) course beginning in September 2016. Beginning in September 2017, instruction based on the new framework for that cohort should continue to the Global History and Geography II (grade 10) course, and subsequent instruction based on the content of the new framework in the United States History and Government course (grade 11) should commence in September 2018.

The content, skills, and social studies practices in the New York State K-12 Social Studies Framework must be built across grades K-12 for students to be successful on the social studies assessments required for a diploma. Instruction in ELA modules that incorporate social studies topics does not replace instruction in social studies, particularly in the development of social studies practices. All teachers of social studies in all grades should review the social studies practices, as well as the common core literacy skills for their courses, and incorporate them, along with content, into their instruction.

The following chart will help guide districts and outline the timeline necessary to plan for and implement instruction aligned to the new Framework in order to prepare students for the new social studies Regents Exams to be first available in June 2018.

Assessment Development and Diploma Requirements

According to the NYS K-12 Social Studies Framework adopted in April 2014, Global History and Geography will be split into two distinct units of study. Global History and Geography I (Grade 9) begins with the Paleolithic Era and continues to a period of Global Interactions from approximately 1400 to 1750. Global History and Geography II (Grade 10) begins with a snapshot of the world at 1750, incorporates the Enlightenment and Industrial Revolution, and continues to the present. A new Regents Exam measuring student knowledge and skills based on the Global History and Geography II (Grade 10) course is under development.

New test items will be piloted in spring 2016 and field tested in 2017. The first administration of the new Regents Examination in Global History and Geography II will follow in June 2018. Subsequently, a new Regents Examination in United States History and Government aligned to the Framework will be administered in June 2019. These changes will impact students beginning grade 9 in 2016. Information about the design of the test and the item types will be released by summer 2016 for the Regents Examination in Global History and Geography II and by summer 2017 for the new Regents Examination in United States History and Government.

At the January 2015 meeting of the Board of Regents, the Board approved regulatory changes pertaining to social studies, as well as multiple pathways to graduation. Beginning in September 2016, students will continue to be required to earn four units of credit in social studies. However, they now will be required to earn two credits in Global History and Geography, in addition to the long-standing requirements for one credit in US History and one half credit in each Economics and Participation in Government or the equivalent.

Effective January 28, 2015, the Commissioner's Regulation regarding multiple pathways to graduation requires a student to pass the ELA Regents Exam, one math Regents Exam, one science Regents Exam, one social studies Regents Exam and one other assessment to fulfill the requirements for a high school diploma. Students may earn a high school diploma by passing either the Global History and Geography Regents <u>OR</u> the United States History and Government Regents <u>AND</u> one other approved pathway assessment. The pathway assessment option is available to students eligible to graduate in June 2015 and beyond, however the new two credits Global History and Geography requirement will first apply to those students who enter grade 9 in September 2016 or thereafter.

Building upon the ideas contained in the Field Guide, the purpose and function of the Toolkit Project is to provide more specific guidance to districts and teachers as they design curricula, instruction, and classroom-based assessments. Instructional resources, including inquiry-based materials, are currently being developed, reviewed, and piloted by New York State teachers. These instructional resources and templates for every course will be aligned to the New York State Framework and incorporate elements of the C3 Framework. Some of these materials will be made available beginning in March 2015 and the rest by fall 2015.

The Toolkit Project will provide professional development support in partnership with the Staff/Curriculum Development Network (S/CDN) and the New York State Council for the Social Studies Conference. Department staff will also provide professional development to various districts, BOCES regions, and organizations, including local Social Studies councils.
