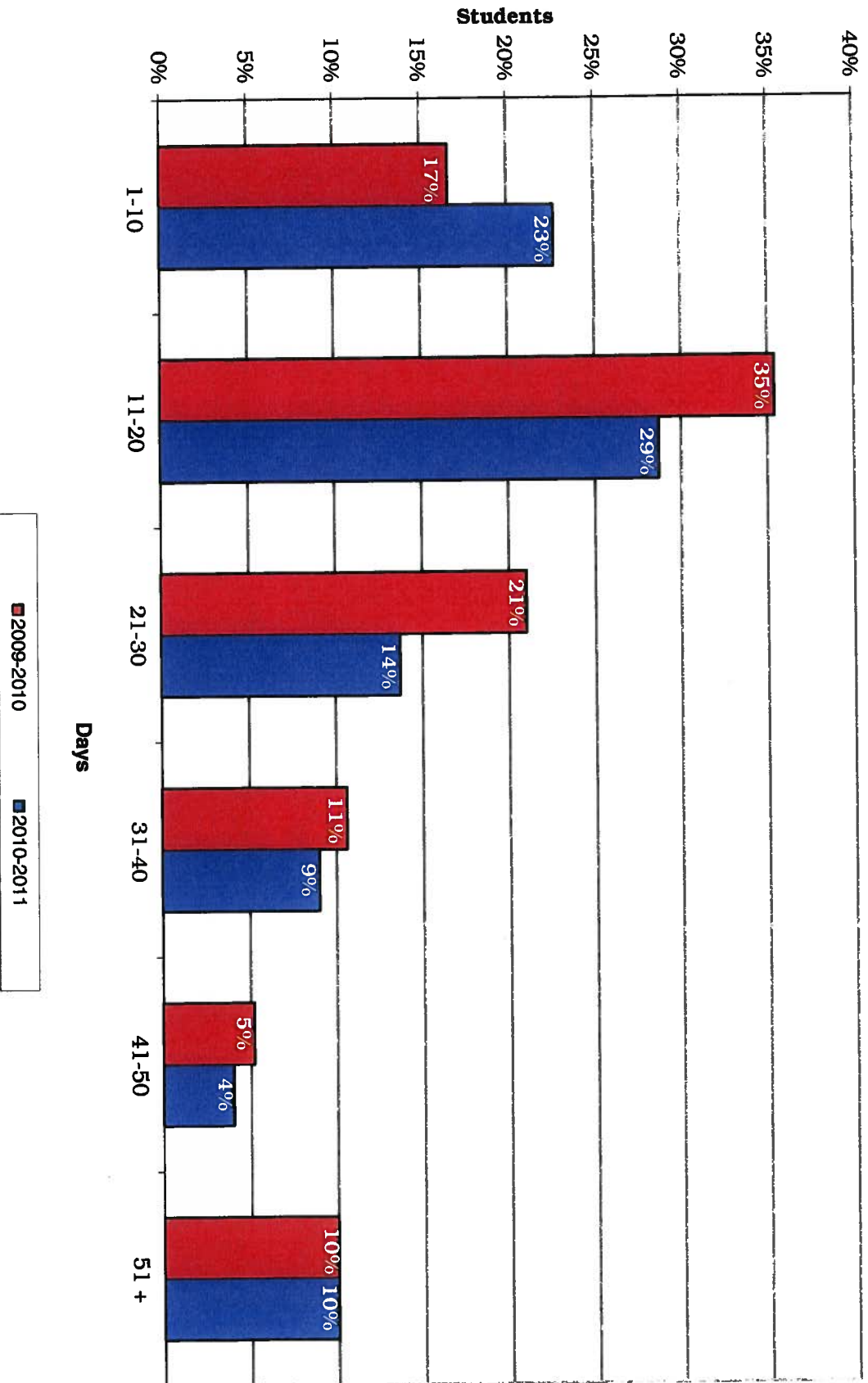


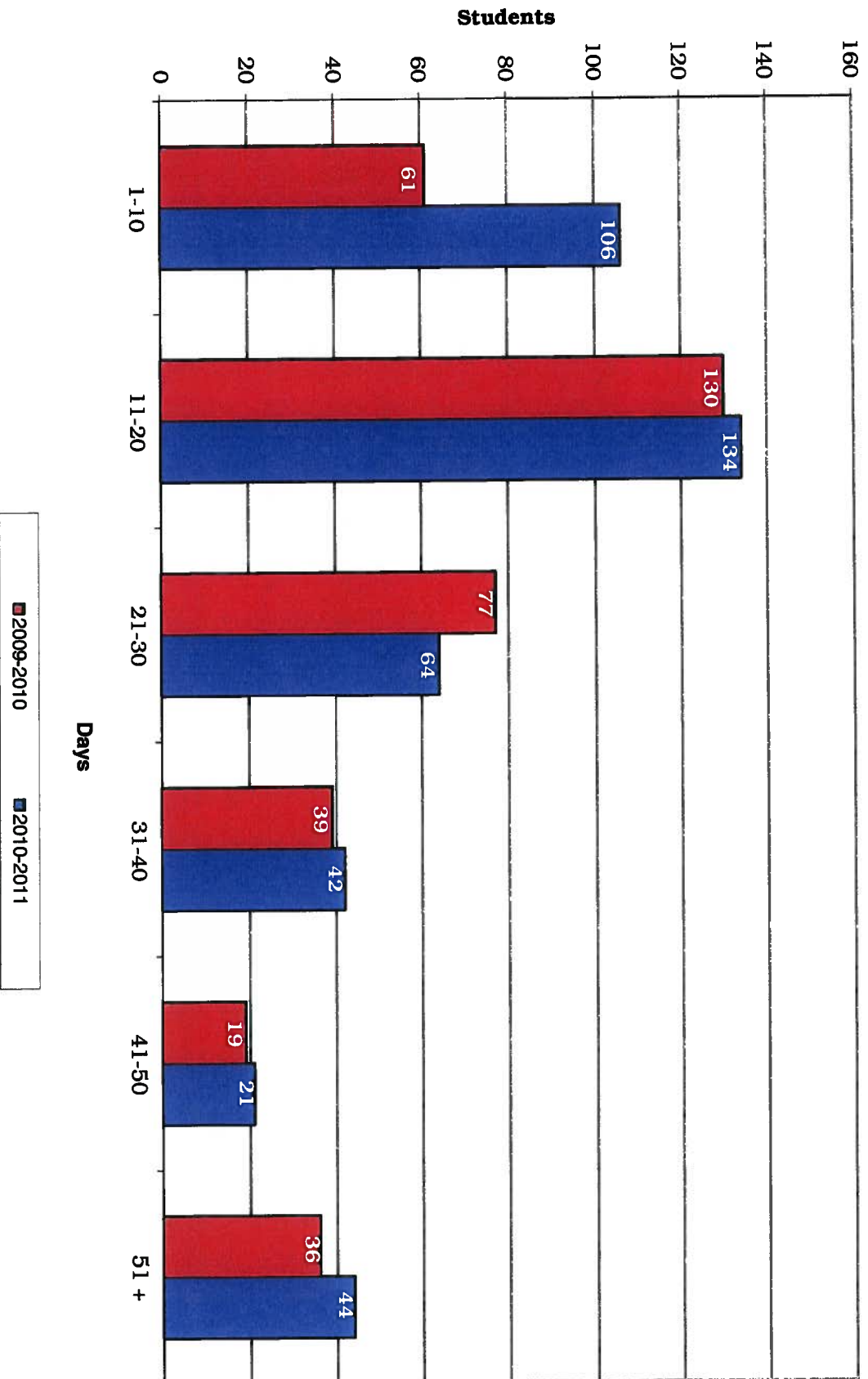
## OCM BOCES Percentage of CTE Student Absenteeism

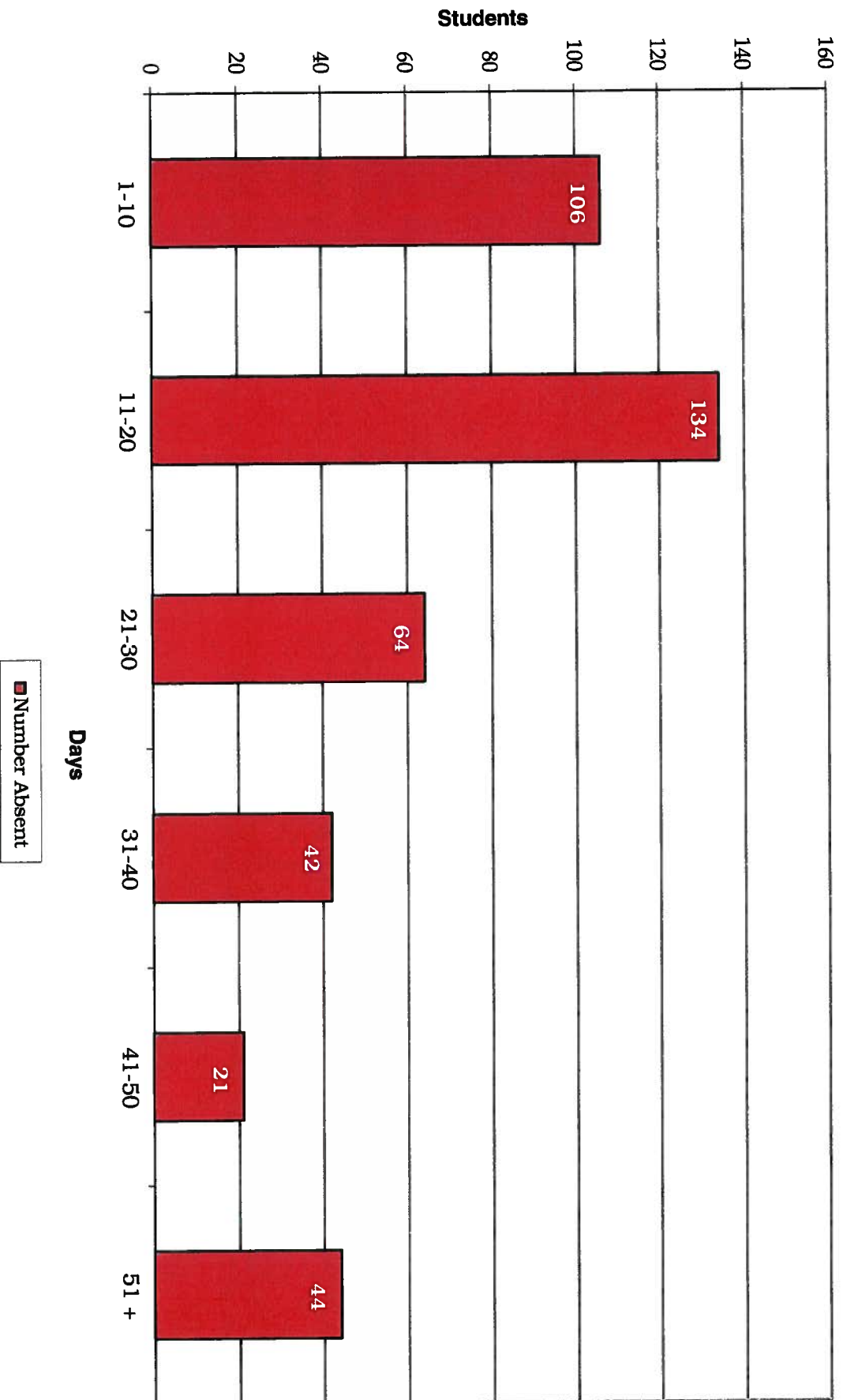

# OCM BOCES CTE Student Absenteeism Comparison



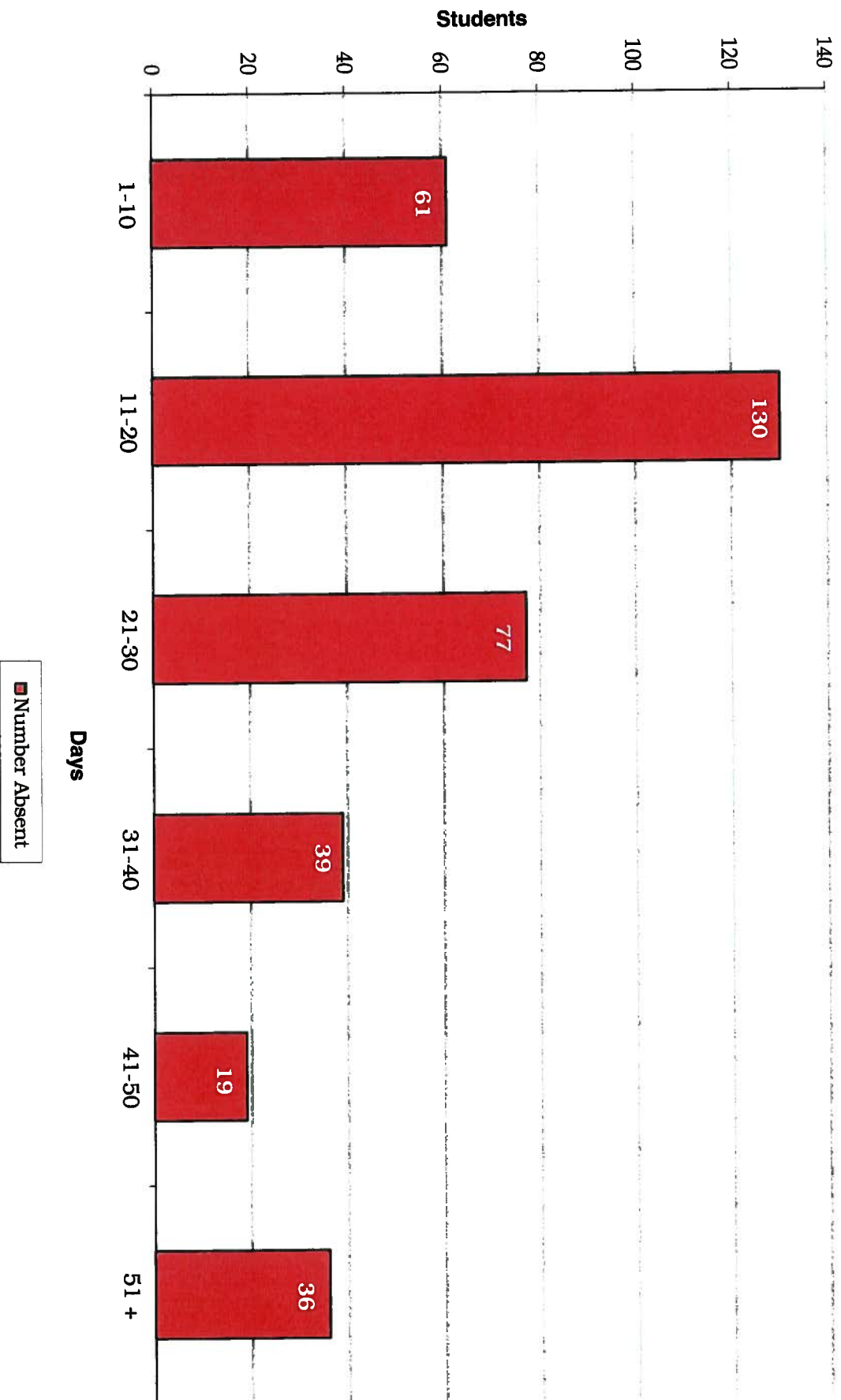

### **ATTENDANCE PLAN**

1. All teachers must take and submit attendance by 9:35 AM and 12:35 PM (teachers must use SIS).
2. The attendance clerk will make a phone call to the parent/guardian of any student that is absent that day. The attendance clerk will verify the absence and remind the parent/guardian about the need for an excuse upon the student's return to school. All phone contacts will be documented on the attendance log.
3. Students will be expected to submit excuses for all absences within two days of returning to class.
4. Upon the fifth absence, the teacher, in addition to the attendance clerk, will contact the parent/guardian by phone to express concern and encourage better attendance. All phone contacts will be documented on the attendance log.
5. Upon 10 absences, the school counselor will contact the parent /guardian by phone and set up a face-to-face meeting. A follow up letter will be mailed as well. At the meeting, a plan for improvement will be created to address the attendance issues. All phone contacts and meetings will be documented and the school administrator will be notified.
6. Upon 20 absences, the school administrator will contact the parent/guardian and home school personnel to set up a face-to face meeting, which will include the school counselor. During this meeting, the improvement plan will be reviewed and/or revised. In addition, new strategies will be discussed and implemented. There will be a letter documenting the outcome of the meeting that will be sent to all parties with copies sent to the Director of Career, Technical and Adult Education and the Assistant Superintendent for Student Services.
7. Upon 25 absences, the school administrator will contact the parent/guardian and home school personnel to set up a meeting to discuss the student's continuation in his/her CTE program. All phone contacts and meetings will be documented.
