## From the District Superintendent

Dear Staff,

I have been reading the headlines recently and wondering what this next year will bring. The recent announcement by Commissioner Mills of his retirement is significant for educators in New York State. Commissioner Mills has been in his position for the past fourteen years and has had an extremely positive impact on our educational system. He has been a strong supporter of programs provided by BOCES and has helped us to grow over the past years. The next few months will be very interesting as the Board of Regents select a new Commissioner.

The Governor recently announced that the state faces a record \$47 billion budget deficit over the next four years, with an expected \$1.5 billion deficit this year and \$12.5 billion next year. The next few months will require us to react to the impact of the state's fiscal pressures. Since state aid to schools is a significant part of the New York State budget, it is safe to say that the next few years will provide many challenges for school districts and for BOCES.

BOCES was designed to provide school districts with cost effective options to collaborate on services. OCM BOCES does this in many ways for students, schools, and communities. Our challenge this year will be to create additional ways to develop and enhance programs to assist our districts to help students be successful. We will be working on how to make sure that we are cost effective and that our services help our districts to become even more cost effective. We'll be talking about this a lot in the next few months.
