WHO IS ELIGIBLE?

You must be employed 50% or more on a salaried basis in order to be eligible for this benefit.

Your spouse and child(ren) are also eligible for coverage. Any child(ren) must be under age 25.

AM I GUARANTEED COVERAGE?
